Challenges of Mental-health Issues in High School **Athletics**

"The two most important days of your life are the day you are born, and the day you find out why."

-Mark Twain High school athletics can be a conduit to helping students prepare for life. Passion around a chosen activity, connection to caring adults, striving for personal goals and meeting high expectations are

ingredients for great triumphs or stumbling blocks which, all too often, can provoke anxietv and

depression.

The relationship between coaches and athletes can be complex. Coaches may feel

base their interactions around techniques and tactics of the sport in order to "win now." Ideally,

coaches will have the desire

and administrative support to have a lifelong impact on their athletes. helping them develop into caring, competent and productive adults. In turn, many studentathletes, relishing the positive feedback, rewards of immediate success and attention of a coach may feel pressured to stay in the athletic-performance

focused part of the coach-athlete relationship, hiding the ways in which they are struggling and in need of emotional and mental support.

There are more high school students using anti -anxiety medications and dealing with depression than ever before.

An estimated 31.9 percent of adolescents have some form of an anxiety disorder.

] Of adolescents with any anxiety disorder, an estimated 8.3 percent have a severe impairment.

1 The prevalence of any anxiety disorder among adolescents is higher for females (38%) than for males (26.1%).

Depression and anxiety disorders are different, but people with depression often experience symptoms similar to those of an anxiety disorder, such as nervousness, irritability and problems

sleeping and concentrating. Each disorder has its own causes and its own emotional and behavioral symptoms.

] Many people who develop depression have a history of an anxiety disorder earlier in life. There is no evidence one disorder causes the other, but there is clear evidence that many people

suffer from both disorders.

Participation in athletics can lend to a culture that emphasizes the need to "just play through it" when injured, stressed or in pain. "No pain, no gain." Student-athletes can quickly allow their athletic

accomplishments (or failures) to become their identity and source of self worth. This emphasis on athletics can cause significant stress and challenges in their lives. Athletics may also represent an avenue of "escape" for students. However, if they never learn how to cope with stress on or off the playing field, they are at risk for a mental-health crisis. Students can

use any number of ways to numb the pain of family issues, divorce, abuse,

disappointment, dating relationship breakups, academic failure, cyberbullying and physical injury. When our coaching staff last year was asked how many had athletes who were showing signs of anxiety and depression, every coach's hand in the room was raised. These behaviors can often be masked or put off by the use of drugs, alcohol, tobacco and thoughts of suicide looking for relief from pressure, anxiety and family issues. In the athletic program at Redmond (Oregon) High School, we received a huge wake-up call a vear ago with the suicide of one of our three-sport athletes. We are now committed to do our best to avoid that ever happening again. A video was developed by the parents of our fallen student, which has registered more than 3.4 million hits on Facebook. This past year, several prominent professional athletes have addressed their own mental and emotional health including NBA players Kevin Love and DeMar DeRozan sharing their struggles with anxiety and depression. Love stated that "Everyone is going through something." A panic attack at a game last year led him to seek professional counseling help. He said he had to "confront the fact he needed help." By doing so, Love pushed back on the unwritten rules about "being a man," asking for help and taking his story public. He also wanted to help decrease the stigma

associated with

emotional and mental chal-

lenges many have endured. Michael Phelps, the winner of

28 Olympic medals. shared his own challenges with anxiety depression recently, admitting he had considered suicide. Breaking his first world record at age 15, Phelps described living a life of dedication. high expectations. challenging physical workouts and dealing with disappointment associated with the pursuit of big goals. Caught up in the world of "real men" do not talk about their problems, Phelps finally became convinced that "it is OK to not be OK." During the past year, the Redmond School District coaching staff has become more attuned to athletes' moods, attitudes, family challenges and potential substance-abuse issues following our athlete's suicide. Recently, one of our coaches sought help for a student- athlete who he knew was

struggling at home and the coach wanted to help. Shortly thereafter, another coach asked us to meet with an athlete who was exhibiting suicidal ideation through photos and other communication online.

This school year, our

This school year, our school district hired two mental-health counselors who are working inside both of the high schools in

our district, giving us access to trained expertise in this challenging area. Still, with the number of athletes in our program, we cannot meet or know the extent or challenges facing every student. In an attempt to bridge the gap, the Redmond High School athletic training staff designed a "Google form" consisting of four questions that is distributed to every fall athlete on a weekly basis. This "Wellness Check" allows our athletes to respond to inquiries regarding sleep, diet, injury issues and mental health. The athletic training staff then follows up on the information personally if there are any concerning responses, and then decides who else needs to be notified. Discussion at the Redmond School District's monthly coaches meetings has focused on Student-Athlete Development (SAD) in specific ways related to overall health in four key areas:

1. Mental Skills Training (emotion management, visualization, positive self-talk and goal setting)
2. Emotional/Mental

Health
3. Physical Improvement (strength, speed and agility)

4. Academic Responsibility and Success

Recently, we were guests on a live Facebook event focused on the mental and emotional health of our athletes, which took

place on National Mental Health Day with the NATA. We discussed some of the specifics of our program and were able to connect with people from around the United States with similar concerns and challenges. In April, we will be presenting a workshop at the annual Oregon Athletic Directors Association (OADA) state conference focused on studentathlete mental and emotional health.

Ultimately, everyone who works with athletes wants to do whatever possible to help them succeed athletically and academically; however, the most important goal is to help build strong and resilient young men and women who will be ready for all of the challenges of life during and after high school.

We do not want to lose another student to suicide because the signs were not recognized, or no one knew where to turn for help. Often, we do not possess the expertise to assist our athletes in these areas of concern; we need to find community resources available to make sure no athlete falls through the cracks.

SPONSOR AND APPLICANT, PLEASE READ BEFORE

COMPLETING THE APPLICATION!

SPONSOR ELIGIBILITY

- (1) A sponsor must have attended the TWO PREVIOUS SUMMER MEET-INGS.
- (2) A sponsor may submit only one application per year.

SPONSOR ELIGIBILITY

- (1) The applicant must be at least 50 years old and have "served 25 years in athletic fields... 15 of the 25 years in Michigan".
- (2) The applicant's name must be submitted by an eligible member.

SPONSOR RESPONSIBILITIES

The sponsor is responsible to see that the completed application and initiation fee is sent to the secretary. After the April Board of Directors meeting, the sponsor should contact his inductee to confirm that the reservation form has been sent to the

Boyne. He should remind his inductee that the induction fee will be forfeited if he fails to attend the Summer meeting, or fails to inform the secretary by June 1st that he will not be attending. The sponsor should be available at the Boyne to meet his inductee and to introduce him to other members so as to make him feel comfortable when he arrives.

APPLICANT RESPONSIBILITIES

The inductee must attend the summer meeting the year in which he has been accepted into the Sports Sages. Upon arrival at the Boyne Lodge, the inductee should register at the Sage registration table in order to pick up registration and other related materials. (The dues for the year will be collected at the registration table.) The inductee should understand that the purpose of the Sages is to meet EACH year "in fellowship, to renew acquaintances and to perpetuate the tradition of achievement and leadership in the fields of athletics and recreation within the State of Michigan".

If the inductee cannot attend the

meeting, he must inform the secretary by June 1st. Upon notification, the secretary will send the initiation fee and application fee back to the sponsor. The application is not carried over from year to year but may be resubmitted by the sponsor. (If a name is resubmitted, it is placed at the end of the current waiting list.)



We hope this memorial tribute will be a meaningful way to help us remember, grieve and celebrate the lives of those coaches lost from our ranks. Note: As this is a new initiative, frequency and manor of the memorial tribute may be subject to revision.

Ken "Coach" Erny, age 67, entered Glory peacefully Sunday, June 4, 2023, at home in Fruitport after a three-year battle with ALS.

What the world may wish to know: The Burlington, New Jersey native graduated with a Bachelor of Arts in Social Science Comprehensive from Cedarville College in Ohio, and a Master of Arts in Teaching and School Administration from Calvin College in Grand Rapids, MI

Ken began his impact within the Fruitport community by coaching soccer and teaching at Fruitport Faith Christian. After the school's closing and a stint as an educator with Calvary Schools, Erny was hired by Fruitport Community Schools in Community Education.

He was selected to serve as the inaugural boys' varsity soccer coach and held that position from 1990-2008, also serving as the school's athletic director from 1996 until he was diagnosed with



ALS in 2020.

Ken, known by many simply as "Coach," poured his heart and soul into countless student-athletes. He understood that athletics must be educational and made it a priority to teach long-lasting life lessons while seeking competitive success

Among his other accolades and accomplishments, Ken helped launch the "No More Sidelines" program at Fruitport High School in 2006, the Student Athlete Leadership Team (S.A.L.T) in 2009 (to mentor young leaders and share wisdom from his tireless reading

and lifelong learning), and the Fruitport Athletic Hall of Fame in 2013.

Ken was truly a "Hall of Famer" in his own right. He was inducted into the Michigan High School Soccer Coaches Association Hall of Fame in 2015, received the Gene Young Distinguished Service Award from the Muskegon Area Sports Hall of Fame in 2022, and later that year was inducted into his hometown Fruitport Hall of Fame.

Ken's servant leadership in the workplace and at home was exemplary, and he valued character and integrity above any accomplishments. His natural humor and witty one-liners regularly brought joy to others. He often cited the famous "Don't Give Up" speech from the late Jim Valvano, and truly sought to laugh, cry, and think each day. He would often pour into those that he noticed were struggling by walking alongside them. His top priorities were faith, family, and Fruitport, and he deeply understood that his life was not his own but that of his loving Creator.

What Ken would want the world to know.

- 1) Always give your best, because life is too short to just go through the motions.
- 2) Always treat people really, really well, because everyone you will ever meet has infinite worth.
- 3) Always demonstrate unconditional gratitude, because no matter what kind of day you've had, no matter how good or bad your performance was, or how bad your diagnosis is, there is always something to be thankful for.

In quoting one of his favorite music artists Matthew West, "this life ain't always wonderful, but what a wonderful life it's been."

MHSCA Membership Benefits

- Sport Association Voice: The MHSCA provides member sport associations another vehicle of communication with the MHSAA. Each year the MHSCA makes a presentation to the MHSAA Representative Council representing issues of our association members.
- Coaching Longevity Awards: Beginning with 10 years of coaching and ascending every 5 years, coaches receive recognition for their years of coaching (10-25 years ear nectical cates, 30-45 years receive plaques, and at 50 years a coach will receive a special crystal recognition).
- MHSCA Coach of the Year Recognition. Each year one coach from your association is chosen by your association to be recognized at the MHSCA State Coach of the Year for your sport
- minSuA Hail or Partie: Each year Up to 15 coaches from the state are selected for induction into the MHSCA Hall of Fame. The Hall is an actual physical entity that is located not the campus of Central Michigan University within the Student Activity Center at the entrance of the old Rose Arena. In addition to meeting the established criteria the individual's sport association must be a member association within the MHSCA.
- MHSCA Jack Johnson Distinguished Service Award: One person per year (teacher, coach, administrator, other) nominated by a member sport association will be honored at the September Hall of Fame banquet for outstanding service to high school sports in Michigan.
- NOCAD Insurance: "As a membership benefit, coverage is provided by the Commercial General Liability Policy issued to the National Crganization of Coaches Association Directors (NOCAD). This policy provides \$1,000,000 (\$2,000,000 aggregate) per member liability coverage to only members of the Michigan High School Coaches Association that pay for the additional coverage through MHSCA member sport associations. "New members taking the NOCAD insurance liability coverage are covered on the first date that they pay their membership due to their sport association through August 1. Members whose sport association paid their for their insurance coverage the previous year are covered August 1—August 1 if they become members of their sport association and their sport association pays their insurance premium. For \$6.00 per coach per year this coverage is hard to to match. Members find more detailed information on the missas and years the "Coaches Corner" drop down link titled 'Insurance."
- Rich Tompkins Multi-Sport Award: This award recognizes athletes that have participated in at least 3 MHSAA sports per year for the 4 years of high school. All nominees receive a high quality certificate. One boy and one girl from each of the four classes of schools (A, B, C, D) will receive a plaque and a scholarship (if eligible) as the MHSCA Rich Tompkins State Multi-Sport Athlete of the Year.
- Gatorade Supplies: Member sport associations receive Gatorade give-away supplies to use at their clinics or all-star games.

- National Federation of High Schools Coach of the Year Recognition: Each year one coach from your association is nominated by your sport association through the MHSCA to be considered for state and national level recognition.
- As a member of the MHSCA you also receive membership into the National High School Athletic Coaches Association (MHSACA) with membership hopefits qualitable.
- NHSACA Coach of the Year Recognition Each year one coach from your sport association can be nominated through the MHSCA for consideration for regional and national recognitions.
- NHSACA Hall of Fame: The MHSCA is allowed to select two coaches each year for induction into the National High School Athletic Coaches Association Hall of Fame.
- NHSACA Kathy Holloway Women in Sports Leadership Award: Presented annually to a female that has promoted female athletics by coaching, serving, supporting, and/or leading high school athletic programs. The nomination process runs through the MHSCA.
- NHSACA Distinguished Service Award: The MHSCA has the opportunity to have one of their members receive this award every 4th

THE HISTORY OF THE NATIONAL HIGH SCHOOL ATHLETIC COACHES ASSOCIATION

A Brief Glance...

In the 50s and early 60s, high school coaches and athletic directors from around the country were invited to annual sessions of the Division of Men's Athletics (DMA) of the NEA/AAPHER group. Special conferences were occasionally scheduled for high school coaches in Washington, D.C., but only as an adjunct of the college physical educator dominated DMA. DMA was one of seven divisions of AAPHER, which was one of 33 departments of the NEA. The high school coaching leaders in America realized that high school sports and coaching were very low in the pecking order of DMA/AA-PHER/NEA.

At one such meeting in 1964, in Washington, D.C., a group of key people were aroused by the lack of real concern for the high school coaching profession and held a called meeting to discuss some alternatives and a new national direction. The concerned people included: Joe Fontana, Paul Smarks, Carey Mc-Donald, Pinky Babb, Bob James, Sam Burke (then president of the National Federation) and many more. A steering committee was appointed with directions to plan another meeting in Atlanta, George in July, 1965.

Dwight T. Keith was elected to serve as the Chairman for the July 10, 1965 meeting. After considerable discussion of pros and cons of organizing a national coaches association, Carey McDonald moved and Fred Farretson seconded that the group organize at that time. The motion passed and the National High School Athletic Coaches Association (NHSACA) was born. A elected after the adoption of the new constitution and by-laws.

The 1966 National Convention was held in Cincinnati, Ohio. Other convention sites included Miami Beach, Florida in 1967 and 1993. San Francisco, California in 1969, Chicago, Illinois in 1970, Atlanta, George in 1971, Pueblo, Colorado in 1972, Jackson Hole, Wyoming in 1973, New Haven, Connecticut in 1974, Orlando, Florida in 1975 1979 and 1986, Portland, Oregon in 1976, Hampton, Virginia in 1977, Tulsa, Oklahoma in 1978, Seattle, Washington in 1980, Biloxi, Mississippi in 1981, Indianapolis, Indiana in 1982, Albuquerque, New Mexico in 1983, Lexington, Kentucky in 1984, Denver, Colorado in 1985 and 1992, New Orleans, Louisiana in 1987, Cromwell, Connecticut in 1988 and 1996, Phoenix, Arizona in 1989, Nashville, Tennessee in 1990, Bismarck, North Dakota in 1991, Des Moines, Iowa in 1994, Tuscon, Arizona in 1995, San Diego, California in 1999, Lincoln, Nebraska in 2000 and the upcoming National Convention in Fargo, North Dakota in 2001.

Dwight T. Keith served as the Executive Secretary from 1965 to 1973 and was a guiding light through the early years of the association. The National High School Coach of the Year Awards Program was initiated in 1968 in football, basketball, track and baseball and continued under that format until wrestling was added in 1971. In 1975, the other 11 sports were included to complete a total recognition program in 16 sports areas for

1965-1966 slate of officers was high school coaches and athletic directors.

> Association membership numbered about 5,000 in the late 60s. The dual association membership was inaugurated in 1969-1970. By 1973, the membership rolls had increased to 8,700 with 11 dual state associations. An aggressive national thrust by the association during the past decade has seen the membership top 50,000 in 1998-1999.

> The NHSACA program of recognition, education, and competition has reached into every state and most schools. The association has achieved a national stature through involvement in varied activities with corporate, governmental, educational groups. NHSACA national office serves as a constant source of information and counsel to individuals and groups from all areas of the country.

> The student recognition programs, such as U.S. Navy All-America selections, involve thousands of boys and girls each year. Hundreds of coaches and athletic directors receive national publicity annually through the coach and athletic director of the year awards program. Close contact and coordination of the NHSACA and the state associations is producing mutually beneficial services.

> From a meager and humble beginning, the NHSACA has assumed a role of leadership which is only limited by the initiative of each member and their state association. The NHSACA is only as strong as the state associations and the challenge to all is at hand.

- · The candidate must have distinguished himself/herself with good coaching ethics and promoted good sportsmanship throughout his/her coaching career. *The AD or principal's signature confirms this.
- Ten (10) years of coaching outside of the state of Michigan may be applied to the application.
- Coaching at any level may be applied if it is a <u>school sponsored</u> interscholastic sport. A maximum of ten (10) years may be allowed for coaching at the collegiate level.
- To receive a <u>general</u> coaching certificate the candidate must have been coaching at least one sport per year at any level for the requested number of <u>years</u>.
- To receive <u>specific</u> certificates for a single sport the candidate must qualify for the specified number of <u>years</u> in that sport.

This can be at any level. You cannot however count more than one level or season for a sport in any one year.

For example, coaching both boys' and girls' basketball during the same school year counts as "1" year; coaching both 7th grade boys and JV boys during the same school year counts as "1" year.

Awards for 30 years and more will have the sports that the candidate coached listed on the plaque. The coach will be presented only one award for each level of service after 30 years.

The Distinguished Service Award (DSA) is given to a person (or persons), either volunteer or staff, who have exhibited valuable professional service (within the MHSCA or among its association membership) including academically, supportive, service, assistance at any level of interscholastic athletics. These criteria are good measures of acceptable candidates and help to assure that recipients have a wide range of "service" that they provide to the profession of interscholastic athletics. Nominations should be submitted on an individual basis, not by a group or on behalf of constituent groups (conferences, affiliates, assemblies, committees, etc.).

The MHSCA Distinguished Service Award does not need to be awarded each year. This award should be bestowed only when the MHSCA Board of Directors committee decides that nominations warrant presentation of the award. This award may be given posthumously.
